## **MISS RIVER QUEEN/TEEN PAGEANT March 24, 2012**

**Eligibility Statement: Due no later than March 5, 2012**

### **MISS RIVER QUEEN CONTESTANTS**

- Must be at least 18 and under 27 years of age as of **February 1, 2013**.
- Must never have participated in a previous national MISS USA Pageant.
- May not have been previously crowned Miss River Queen.

### **MISS RIVER TEEN CONTESTANTS**

- Must be at least 15 and under 19 years of age as of **February 1, 2013**.
- Must never have participated in a previous national MISS TEEN USA Pageant.
- May not have been previously crowned Miss River Teen.

### **ALL CONTESTANTS**

- Must not be married, never have been married, and never have had a marriage annulled. Must never have given birth to a child, can not be pregnant or be a parent.
- Must be of good health and moral character.
- Must be a naturally born female, a citizen of the United States, and at least one of the following must be true:
  - Must now reside in Tennessee as their permanent and primary residence for a period of at least six (6) months immediately prior to the beginning of their state pageant (although they may have attended college or University elsewhere); or
  - Must have resided in Tennessee as a full-time student at a college or university for one entire semester immediately prior to the beginning of their state pageant, and they are continuing to reside in their state as a full-time student (although they may have spent or be spending the summer in another state).
- Must agree, that if selected, they will participate in the Miss TENNESSEE USA/TEEN USA Pageant, and will abide by all the rules and regulations governing that pageant. If they win the MISS TENNESSEE USA/TEEN USA Pageant, they must agree to participate in the MISS USA/TEEN USA PAGEANT, and to abide by the rules and regulations governing that pageant.
- No contestant or any member of their immediate family can be employed by Miss Universe L.P. LLLP, any State Director in the MISS USA and/or MISS TEEN USA Pageant system, NBC Inc., or any of its subsidiaries, Ernst & Young, or any of its

subsidiaries, Donald J. Trump, Trump Pageants Inc., The Trump Organization, NBC Universal Inc., or any of their subsidiaries or affiliated or related companies. (If contestant or any member of their immediate family is employed by any of the foregoing or any firm or corporation controlled or affiliated with any of them, then they must notify the state director immediately, in writing, so that their eligibility may be determined.

- Must agree that if selected, they will not participate in any other pageants during the time they hold this title, unless authorized in writing by Miss River Queen/Teen Pageant Committee.
- **Must agree that if selected, they will make themselves available during the Rivers & Spires Festival (April 19-21, 2012) for promotional and marketing purposes.**
- Must agree that if selected, they will represent Clarksville/Montgomery County and will abide by the rules and regulations governing the pageants.
